SOUTH CENTRAL IDAHO – School is almost back in session all over Southern Idaho. South Central Public Health District (SCPHD) wants to ensure your child's health and safety during this school year with our comprehensive back-to-school vaccination clinics. Our nurses and customer service representatives will be available to look up your child's vaccine records and provide any vaccines that they might need. SCPHD can bill to private insurance or Medicaid. For those who are uninsured, we will work with you on low-cost options in order to provide vaccines for your children.

"Vaccine-preventable diseases have not gone away," said Melinda Bauman, Registered Nurse and SCPHD Immunization Coordinator. "Like eating healthy foods and exercising, immunizations play an important role in keeping us healthy."

All upcoming clinics will have immunizations for students aged Kindergarten through 12th grade and are open to all students regardless of where they attend school. No appointment is necessary for these clinics. If you are unable to attend our school clinics, contact an SCPHD office to schedule an appointment.
